A complete list of rules will be given to you upon registration.

You will receive a tag for each dog that must be brought with you, and should be visible, every time you use the dog park. This will be your proof of registration.

There is a \$20.00 yearly fee per family which goes to replace needed items.

Participation agreement and assumption of risk and liability insurance.

1. All children under the age of 13 years old must be in the company of an adult at all times inside the dog park. They should never run or make loud noises.
Children under the age of 5 years old are not allowed in the park at all.
2. Puppies under 4 (four) months old are not permitted in dog park.
3. **Dogs must be strictly supervised. Dog owners must remain in the fenced area with their dogs, and must be within sight range. Additionally, owners must have voice control at all times.**
4. Dogs less than 30 lbs must use small dog park.
5. Do not place large dogs in small dog park or vice versa.
6. No smoking or eating inside the park.
7. Dog treats are not permitted in park.
8. You must supply your own water and drinking bowl for your dog.
9. **Be considerate of other people and dogs, and kindly pick up your dog's waste. Bags and pails are available throughout the dog park.**
10. Aggressive dogs will not be permitted in park. At first sign of aggressive behavior, immediately leash and remove dog.
11. Dogs in heat will not be permitted in Dog Park.
12. Please do not bring sick dogs to park.
13. No animals other than dogs may be brought into the fenced area.
14. Only paid up-to-date members will be allowed to use the park.
15. The dog park is open from dawn to dusk. (There are no lights at Dog Park).
16. All dogs **MUST** be off leash while in and entering dog park. Leash must be immediately placed on the dog upon exiting. Dogs should be leashed only in the event of emergency or altercation.
17. Before opening second gate into the park, please close and lock the first gate so all are contained safely.
18. All owners must show proof of current rabies vaccination certificate and must be licensed. Rabies tags need to be worn on dogs collar at all times. If dog is not licensed you have 5 (five) days in which to license your dog(s).
19. Spectators should remain outside the fenced in area.
20. No more than 3 (three) dogs per person allowed on any single visit.
21. Owners are liable for any injury or damage caused by their dog and are fully responsible for their dog's actions.
22. Trainers are not allowed to use the park to conduct business.
23. Any incident or problem should be reported to the Putnam Valley Parks and Recreation Department (845)526-3292 or the Putnam Valley Dog Control Officer (845) 526-3293 between the hours of 8am – 4pm.
24. In the event of an emergency call 911.

I understand that permission from the Town to use the dog park is conditional upon compliance with the above rules and regulations, and that by not abiding by them I forfeit my ability to participate.

I also understand that by providing an area where dogs are unleashed and there are people including children, accidents may occur to either me, my dog(s) or others, and I do agree to assume such risks.

I further agree to release, discharge, hold harmless and indemnify the Town of Putnam Valley and all of its officials, agents, officers, employees and representatives from liability for any and all claims for injuries, damages and/or losses whatsoever to any person or animal (including but not limited to disability and death) or property which may arise out of, result from or be associated with the use of or presence on the dog park by myself and/or my dog(s).
